  - Noble Street (S.T.H. '11' Village Road): 8" sanitary sewer replacement; 6" water main to be replaced with 8" water main; storm sewer replacement and additions; curb and gutter replacement and installation; sidewalk replacement; full street reconstruction; and yard landscaping/restoration
  - Cole Street (Sheldon Street Noble Street): 8" sanitary sewer replacement; 8" water main extension for looping purposes; storm sewer replacement and additions; curb and gutter installation; full street reconstruction; and yard landscaping/restoration
  - Gratiot Street (Noble Street Village Road): 8" sanitary sewer replacement; 8" water main extension for looping purposes; storm sewer replacement; curb and gutter installation; full street reconstruction; and yard landscaping/restoration
- Estimated Project Costs = \$2,295,000
- LMI % = 61.39%
- Amount to be requested for project (\$1,000,000)
